

**PDL Visionspec Consultation Promotion
April 2026 to January 2027
TERMS AND CONDITIONS**

1. Information on how to enter and the prizes form part of these Terms and Conditions.
2. Any entry which does not comply with these Terms and Conditions is invalid.
3. Participation in this promotion is deemed acceptance of these Terms and Conditions.
4. Entry is only open to New Zealand residents aged 18 years or over.
5. Employees (and their immediate families) of the Promoter, and agencies associated with this promotion are ineligible to enter.  - Select the Opt-in button to subscribe to receive promotional newsletters from PDL and Schneider Electric via email. The status of the email address must remain 'subscribed' at the time of the prize draw; and
